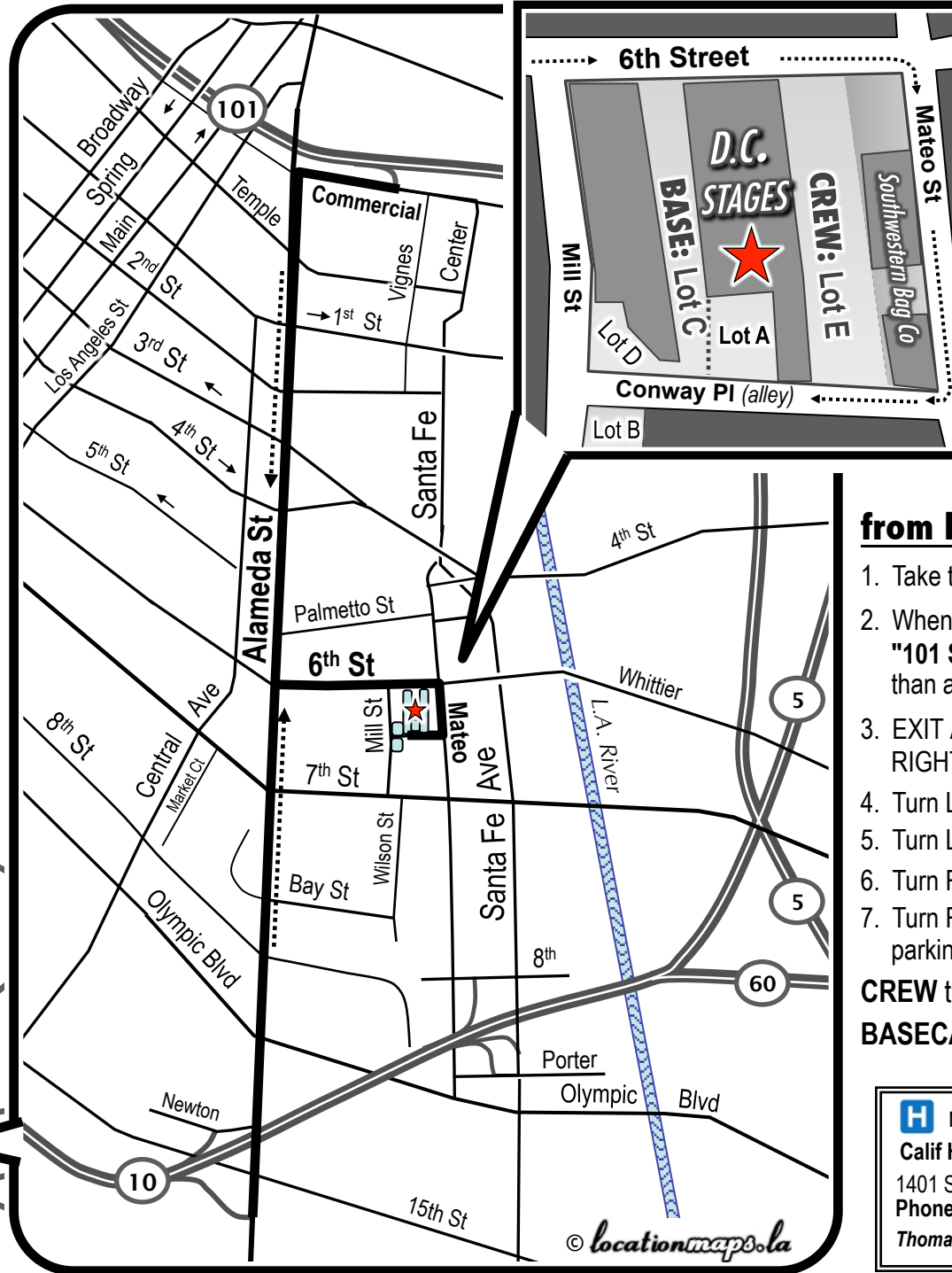
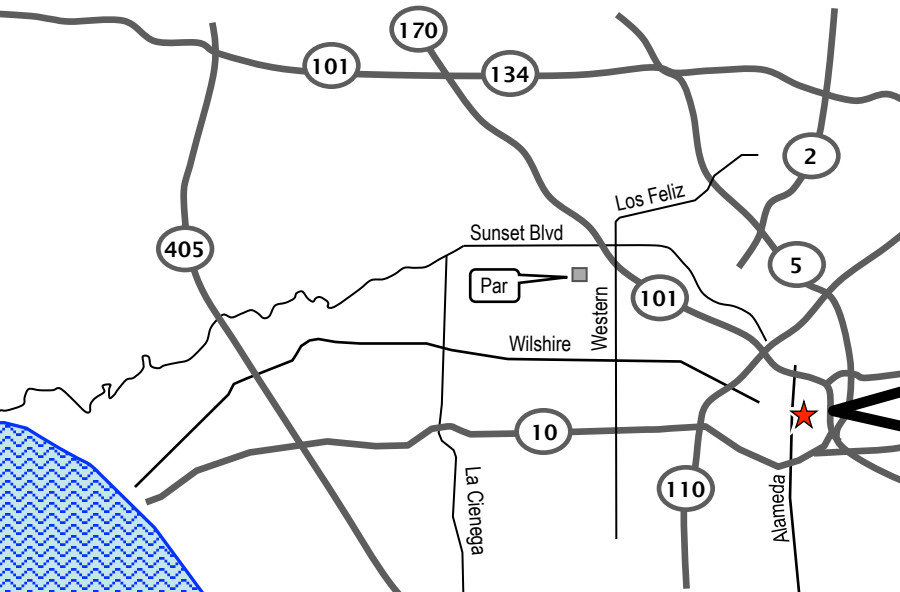

**from WEST L.A. / Santa Monica**

1. Take the **10 FWY East** to downtown L.A.
2. EXIT **ALAMEDA ST** - turn **LEFT** (north) from offramp & travel 1.1 miles to 6th Street
3. Turn **RIGHT** onto **6th ST** heading east
4. Turn **RIGHT** at 1st stoplight onto **MATEO ST**.
5. Turn **RIGHT** onto **CONWAY PL** alley to DC Stages parking lots – follow signs & park as directed

**CREW** turn **RIGHT** into Lot E (see diagram)  
**BASECAMP** in Lot C / **TRUCKS** in Lot A

**from Hollywood / The Valley**

1. Take the **101 HOLLYWOOD FWY South** to downtown
2. When approaching downtown, follow **LEFT** 3 lanes towards "**101 South to 5 South / 10 East / 60 East**"- continue less than a mile past the 110 FWY to Alameda St EXIT
3. EXIT **ALAMEDA ST / Union Station** - turn **RIGHT** onto **COMMERCIAL ST** from offramp
4. Turn **LEFT** onto **ALAMEDA ST** and go 1 mile south
5. Turn **LEFT** onto **6th ST** heading east
6. Turn **RIGHT** at 1st stoplight onto **MATEO ST**.
7. Turn **RIGHT** onto **CONWAY PL** alley to DC Stages parking lots – follow signs & park as directed

**CREW** turn **RIGHT** into Lot E (see diagram)  
**BASECAMP** in Lot C / **TRUCKS** in Lot A
